Yip Associates' fees of \$15,702.50 are **APPROVED**. The Receiver is authorized to pay Yip Associates \$12,562.00, representing 80% of the approved fees (\$15,702.50) earned during the Twelfth Application period of January 1, 2023 through March 31, 2023, with the remaining 20% of the approved fees to be paid out at the discretion of the Court as part of the final fee application submitted at the close of the receivership.

Development Specialist Inc.'s fees of \$60,058.40 and expenses of \$5,763.77 are **APPROVED**. The Receiver is authorized to pay Development Specialists, Inc. the sum of \$53,810.49, representing 80% of the approved fees (\$60,058.40) and 100% of expenses (\$5,763.77) earned during the Twelfth Application period of January 1, 2023 through March 31, 2023, with the remaining 20% of the approved fees to be paid out at the discretion of the Court as part of the final fee application submitted at the close of the receivership.

Rehmann's fees of \$49,053.75 are **APPROVED**. The Receiver is authorized to pay Rehmann \$39,243.00, representing 80% of the approved fees (\$49,053.75) earned during the Twelfth Application period of January 1, 2023 through March 31, 2023, with the remaining 20% of the approved fees to be paid out at the discretion of the Court as part of the final fee application submitted at the close of the receivership.

E-Hounds, Inc.'s fees of \$2,985.00 are **APPROVED**. The Receiver is authorized to pay E-Hounds, Inc. \$2,388.00, representing 80% of the approved fees (\$2,985.00), earned during the Twelfth Application period of January 1, 2023 through March 31, 2023, with the remaining 20%

The Receiver is authorized to pay Burnet, Duckworth & Palmer LLP \$319.00, representing 80% of the approved fees (\$330.00) and 100% of the expenses (\$55.00), earned during the Twelfth Application period of January 1, 2023 through March 31, 2023, with the remaining 20% of the approved fees to be paid out at the discretion of the Court as part of the final fee application submitted at the close of the receivership.

Bell Gully's fees of \$5,876.46 and expenses of \$146.91 are **APPROVED**. The Receiver is authorized to pay Bell Gully \$4,848.08, representing 80% of the approved fees (\$5,876.46) and 100% of the expenses (\$146.91) earned during the Twelfth Application period of January 1, 2023 through March 31, 2023.
